

# KOBELCO WELDING OF EUROPE B.V.

Dear Sir/ Madam,

Great Britain (England, Wales and Scotland) left the European Union and therefore any imports of substances, mixtures or articles into its territory are no longer subject to the EU REACH regulation. Great Britain implemented the REACH regulation with only minor adaptations and called it UK REACH. REACH stands for Registration Evaluation Authorisation and restriction of Chemicals.

In accordance with article 8 (1) of UK REACH it is possible for manufacturers and formulators of substances, as well as manufacturers of articles, to appoint a Only Representative. This OR takes over several obligations from importers in the supply chain of the non-UK manufacturer, including:

- Submission of a Downstream User Import Notification (DUIN) before October 27<sup>th</sup> 2021
- Registration of substances before the relevant deadlines (2023, 2025, 2027)
- Notification of SVHCs in articles

This letter is to confirm that you are importing into Great Britain products and/or articles containing substance(s) manufactured by Kobelco Welding of Europe B.V. outside Great Britain according schedule 1 to 4. We hereby inform you that from October 15, 2021, Kobelco Welding of Europe B.V. have appointed

as her only representative ("OR") according to Art. 8(1) of the UK REACH Regulation for notification and registration of our substances listed in Table 1 of this letter.

Due to the aforementioned appointment of an OR you may be relieved from your notification and registration obligations as an importer under UK REACH for the substance(s) Kobelco Welding of Europe B.V. has included in this OR agreement.
